NYSDEC Air Operating Permit Updates

The DEC has updated its Air Operating Permit Program

The New York State Department of Environmental Conservation has updated its Air Operating Permit Program found in 6 NYCRR Parts 200, General Provisions; and 201, Permits and Registrations (Part 201), effective February 22, 2013. The last substantial overhaul of Part 201 occurred in 1996. These regulations apply to any entity that operates one or more stationary air emission sources in the State of New York.

To begin with, several minor changes to Part 201 were made as part of this update:

First, facility owners or operators still holding certificates to operate (Air 100's) will be required to submit a permit or registration application to the Department in an effort to update their facility information and ensure their continued compliance with current applicable requirements. This requirement will be phased-in to help mitigate any potential impacts on facility owners and operators.

Second, the Department modified the provisions of Part 201 for emission sources operating on a temporary basis.

Third, the Department made several minor changes to the cap-by-rule provisions in an effort to make them more efficient and easier for facility owners and operators to implement. Structurally, the cap-by-rule provisions in section 201-7.3 have moved to the minor facility registration section 201-4.5. The emission capping provisions used to accept federally enforceable emission caps have moved from section 201-7.2 to 201-7.1.

Finally, the Department revised the list of activities that are exempt from state (Continued on page 2)

permitting requirements. The changes were made to make the list more consistent with federal and state requirements and to add six new activities.

Several more substantial changes were also made as a part of this rulemaking:

First, the permit and registration application requirements were revised to require additional information that has typically been requested during the permit review process.

Second, the Department initiated term limitations for both new and modified air facility registrations and state facility permits. The expiration date on current registrations and state facility permits will not change, unless the permit is modified. Newly issued and modified registrations and state facility permits will be issued with a 10 year term.

Third, the rulemaking established mass emission thresholds and corresponding permitting requirements for facilities emitting one or more of the 62 persistent, bioaccumulative or toxic (PBT) compounds listed in subpart 201-9. The Department has concluded that these 62 compounds, which are highly toxic to humans and animals and have high rates of persistence in the environment, need to be more closely monitored, and where necessary controlled. The list of the affected compounds and their associated emission thresholds are now used to determine whether a facility needs to apply for and obtain a state facility permit instead of a registration. Accordingly, some existing registered facilities may be required to upgrade to a state facility permit if their annual actual emissions of one or more of the listed compounds exceed the listed threshold.

Mr. Chris LaLone, P.E., Chief of the Permitting and Compliance Section in the Division of Air Resources will present the changes to Part 201 at our April 25, 2013 meeting. This will be a great opportunity to learn more about the recent changes to the air permitting program. Scholarship & Grant Update

The Earth Day Grant Program had another great year. We were able to award funding for 5 very great projects.

The following is a summary of the projects we awarded.

- 1) \$200 to the Erie County Soil & Water Conservation District as seed money to help fund the Erie County Envirothon which is an annual outdoor environmental program open to all high school students in Erie County and is presented in two parts. Workshop Day on March 26th and Competition Day on April 25th at the Village Green Center in Elam NY
- 2) \$300 to Cardinal O'Hare High School for "Garden Planting and Science Afloat". \$50 of the funding went towards seeds and peat moss for their gardens they put in previous years with Earth Day Grant money and the remainder went towards with helping to supplement a unique educational opportunity called "Science Afloat". Students learn topics relevant to the Great Lakes' unique and delicate ecosystem while on board the 73' Schooner "Spirit of Buffalo". The program is sponsored by Buffalo Urban Outdoor Education. More information, can be found on their website www.buoe.org/science-afloat.asp. An interesting aspect of this funding request is that they only wanted to partially fund the trip with grant money to keep the costs reasonable for the students but they wanted to ensure the students paid some also to ensure they felt vested in the trip.
- 3) \$325 to Stanley G Falk School (Ressler Location) for "**Gardening for Change**" to start up a garden similar to one that their sister school has started up three years ago. Stanley G Falk School is an approved NYS Education Department Special Day School that provides educational programming for students from 5-21 years old that have special learning, social and emotional needs.
- 4) \$325 to Stanley G Falk School (Cambridge Location) for "**Urban Garden Take 3**" This is the third year of their very successful program. The first year was to obtain supplies needed, the next year was to build a greenhouse and this year is to get better soil for the area because the area they have is mostly clay and causing them some gardening issues.
- 5) \$300 to the JFK Environmental Club at JFK High School for their "**Lights Out Program**" for better communication of energy conservation at the school in keeping lights off when not needed

<u>The AWMA 2013 ENVIRONMENTAL POLLUTION PREVENTION AWARD</u> was presented to: <u>St. Christopher School</u> for its city – <u>Heliopolis</u>

This school was picked by judges – Rick Allen, Gary LaLiberty, and Hal Pierce - at this year's annual Future City Competition and Award Ceremony held at Mount Saint Mary Academy on January 19.

The winning school planted Duckweed on the outside of their buildings to remove pollution from the air. The duckweed can then be either used as a fertilizer or as a Bio-feed for livestock. Their buildings had roof gardens. Storm water was filtered and reused for Sanitary purposes. Beneath the roads they installed Nano Membranes and used Bacteria to remove Pollution. They had electric folding cars to take up less space. They had a Waste-to-Energy plant

The workmanship of the exhibit was excellent and all students participated in the presentation.
