Regulate and promote the diversion of organics (wasted food, yard waste, biosolids, food processing waste, etc.) from disposal to beneficial uses.



Food Donation and Food Scraps Recycling Law

Effective January 1, 2022, businesses that generate an annual average of two tons of wasted food per week or more must...

- 1. donate excess edible food; and
- 2. recycle all remaining food scraps if they are within 25 miles of an organics recycler (composting facility, anaerobic digester, etc.).

Designated Food Scraps Generators (DFSG)

- Businesses that generate ≥ 2 tons per week (annual average) at a single location.
- For multiple small entities (mall or college campus) depends on who contracts for waste management.

Exclusions:

- Hospitals
- Nursing Homes
- Adult Care Facilities
- Elementary and secondary schools

- New York City (local law 146)
- Generators serviced by a mixed waste recycler (Delaware County)
 - Farms



Designated Food Scraps Generator Metrics

Food Industry Sector	Minimum # of Employees To Generate A Minimum of 2 tons/week of wasted food
Food Wholesale and Food Distribution	9 employees
Food Retail	69 employees
Supercenters/Big Box Stores	208 employees
Colleges (Residential / Non-Residential)	1,465 students / 5,474 students
Hospitality	105 employees
Correctional Institutes (County Jails / State)	570 inmates / 877 inmates
Restaurant (Full Service / Limited Service)	69 employees / 94 employees

Note: This is not a complete list or the final metrics



Preliminary Business Analysis

Sector	Number of Establishments
College & Universities	84
Correction Facilities & Jails	31
Hospitality	75
Restaurants (Limited & Full Service)	230
Grocery & Specialty Food	400
Supercenters	75
Wholesale & Distribution	350
Approximate Total	1,245

Note: Some of these establishments already have robust donation programs, are recycling their food scraps, employing waste reduction initiatives, etc.



DEC developed new regulations

Part 350

New regulations used to implement the Food Donation and Food Scraps Recycling Law.

Public Comment Period Closed April 27, 2021

Part 361

Existing regulations covering the permitting and operation of solid waste management facilities (organics recycling).

No changes made.



Part 350 Regulations

- 350-1: General
- 350-2: Designated Food Scraps Generators
- 350-3: Generators, Organics Recyclers, and Transporters Lists
- 350-4: Transporter and Solid Waste Management Facility Responsibilities



DFSG Waiver Process

Temporary Waiver

- Prove undue hardship
- No longer than 1 year in duration, can be renewed
- Form posted to DEC website June 1, 2021
- Submit to <u>FoodScrapsLaw@dec.ny.gov</u> by October 1, 2021 for 2022 reporting year



Waiver Process - Justifications

- Generator does not produce more than 2 tons of food scraps per week (annual average)
- The total cost of organics recycling is at least 10% greater than the total cost of landfilling or combustion
- There are no organics recycler(s) within 25 miles with sufficient capacity
- □ A food scraps transporter is not available to service the generator
- Unique circumstances that apply to the generator



Food Donation Efforts

- Working with NYS Department of Health and NYS Department of Agriculture & Markets on consistent regulatory enforcement



Partnering with Feeding New York State

Funding, Outreach, and Collaboration

- \$1.5 million COVID-19 relief funding
- **NEW -** \$500,000 Donation Technical Assistance for Businesses
 - Manage a call center for information on donating
 - Educate on proper food safety practices when donating food
 - Enhance connection between businesses, food banks, and other emergency food relief programs






A Look at the Organics Recycling Community in New York State

Composting in NYS

- Regulated by DEC
- Currently ~60
 regulated facilities
 allowed to accept food
 scraps



Anaerobic Digestion in NYS

- Regulated by DEC
 - Part 360 Solid Waste Program
 - Concentrated Animal Feeding Operation (CAFO) program
 - Water Resource Recovery Facilities (WRRF)
- Five Permitted Part 360 Anaerobic Digesters
- A number of digesters located on CAFOs
- ~130 ADs at WRRFs

OVERVIEW OF NYS FOOD DONATION & FOOD SCRAPS RECYCLING LAW

Beginning January 1, 2022 the <u>New York State Food Donation and Food Scraps Recycling Law</u> requires designated food scraps generators to donate edible food and recycle food scraps if a organics recycler exists within 25 miles. A designated food scraps generator (DFSG) produces at least 2 tons of food scraps per week. The Law also contains requirements for food scraps transporters, transfer facilities and other intermediaries, combustion facilities, and landfills.

EXAMPLES OF DESIGNATED FOOD SCRAPS GENERATORS (DFSG)

DFSG include, but are not limited to:

Grocery Stores

Sport Arenas

Restaurants

- Venue Centers

Colleges

Etc.

Hotels

This law does not include businesses within New York City (<u>local law 146</u> already in place), hospitals, nursing homes, adult care facilities and K-12 schools.

HOW TO IDENTIFY A DFSG IN YOUR SERVICE AREA

DEC will publish a list of DFSGs by June 1, 2021 and will be available on the DEC website.

TRANSPORTER RESPONSIBILITIES UNDER THE LAW

If you are a transporter that collects food scraps from a DFSG (that does not have a waiver), you must deliver the food scraps to an organics recycler (composting facility, anaerobic digester, etc.) or to a transfer facility or other intermediary that will transfer the food scraps to a recycler. The food scraps must not be delivered to a landfill or to a combustion facility. The designated food scraps generator is responsible for properly separating their organics.

WHERE TO TRANSPORT FOOD SCRAPS

DEC will publish a list of organics recyclers across the state that are interested in accepting food scraps from designated food scraps generators. This list will be published on the DEC website.

If there is an organics recycler within 25 miles of a designated food scraps generator, the law requires that the food scraps must be recycled, but not that they have to be recycled at an organics recycling facility within 25 miles.

• Annual grant program for community organizations and local government agencies based and operating in New York State.
